1. CALL TO ORDER AND CONFIRMATION OF QUORUM

Dr. McGrew called the meeting to order at 1:03 PM and confirmed a quorum.

2. ADOPTION OF THE AGENDA (action item)

Sec. Collins **MOVED** to adopt the agenda. Sec. Johnson **SECONDED**. There was no discussion. All were in favor. Motion **CARRIED**.

3. <u>APPROVAL OF MINUTES (action item)</u>

Sec. Johnson **MOVED** to approve the March 16, 2021, General Meeting Minutes. Sec. Collins **SECONDED.** There was no discussion. All were in favor. Motion **CARRIED.**

4. <u>REPORT FROM THE CHIEF MEDICAL INVESTIGATOR</u>

Dr. Jarrell opened her report by congratulating Dr. McGrew on her upcoming retirement. Dr. Jarrell also thanked Dr. McGrew for her service to UNM and OMI.

Faculty Updates:

Dr. Jarrell announced two new Forensic Pathology Faculty members. Emily Helmrich, DO will finish her Forensic Pathology Fellowship with OMI at the end of June. She will take a break and start her new faculty position with OMI in August. Sophia Rodriguez, MD will start her new faculty position with OMI at the end of August. Dr. Rodriguez completed her Forensic Pathology Fellowship at OMI in 2015. With the hiring of Drs. Helmrich and Rodriguez, OMI will have two vacant forensic pathology faculty positions. Dr. Jarrell introduced Jamie Elifritz, MD, an Assistant Professor of Radiology at UNM. Dr. Elifritz will provide forensic radiology consultation and teach at OMI. Dr. Jarrell congratulated OMI faculty Drs. Decker and Elifritz who are Co-Principal Investigators on NIH Grant Proposal that has been accepted to move forward with Protocol Development. If fully awarded, the funding will be over 3 million for 4 years.

Dr. Ross Zumwalt will be fully retiring from clinical service at UNM, after 34 years of service, 23 years as OMI Chief. Dr. Zumwalt will take on another role at Mayo Clinic, working with Dr. Ross Reichard, a former forensic pathology faculty at OMI. Drs. Zumwalt and Reichard will work to form a forensic pathology fellowship program there. Dr. Zumwalt's wife, Dr. Cheryl Willman has also accepted a position to be the Cancer Center Director at the Mayo Clinc.

COVID-19 Related Expenses:

Dr. Jarrell presented the following slide and noted that OMI has put in for FEMA reimbursements and has received one installment at \$114,000, and a seconded installment of \$98,000 has been obligated. There will be three more reimbursement requests.

Dr. Jarrell reminded the board that in the last board meeting, Sec. Johnson recommended to look at how much the OMI would save by providing in-house transportation. The next slide shows 3 options of in-house transportation costs. There is a potential savings of \$60,000 to \$70,000 a year. OMI would ask for legislative funding to cover the purchase of the vehicles.

6. BUDGET UPDATE:

Dr. Jarrell presented a slide to the board and gave an update about the OMI budget. Dr. Jarrell noted that the NMS Toxicology line item is blank because the funding for Pending Toxicology is covered by two grants. Non-Pending toxicology is not currently funded. OMI ran out of funding for Non-Pending tox in December. Dr. Jarrell clarified Pending Toxicology versus Non-Pending Toxicology. Non-Pending tox are cases where toxicology is not needed to determine cause and manner of death. Examples are, motor vehicle collisions, and homicides. However, the data from Non-Pending tox cases are used for The NM Department of Public Safety (DPS), The NM Department of Health (DOH), and legal proceedings. By statute the OMI is not obligated to run toxicology tests in Non-Pending toxicology cases, samples are collected and held until funding becomes available.
