1. CALL TO ORDER AND CONFIRMATION OF QUORUM

Chief Johnson called the meeting to order at 1:02 PM and confirmed a quorum.

2. ADOPTION OF THE AGENDA (action item)

Sec. Trujillo **MOVED** to adopt the agenda. Mr. Houston **SECONDED**. There was no discussion. All were in favor. Motion **CARRIED**.

3. APPROVAL OF MINUTES (action item)

Sec. Trujillo **MOVED** to approve the June 10, 2021, General Meeting Minutes. Mr. Houston **SECONDED.** There was no discussion. All were in favor. Motion **CARRIED**.

4. ELECTION OF BOARD CHAIR (action item)

Chief Johnson **MOVED** to elect Sec. Scrase to be the Board Chair. Sec. Trujillo **SECONDED**. All were in favor. Motion **CARRIED**.

5. REPORT FROM THE CHIEF MEDICAL INVESTIGATOR

Retirement of OMI Director of Operations:

Dr. Jarrell recognized Yvonne Villalobos for her years of service to OMI. Ms. Villalobos will retire from OMI at the end of this year.

Cooler Project:

New Mexico Department of Health provided funding for two additional permanent coolers.

- Allows additional space throughout pandemic and increased case number trajectories.
- OMI currently assists with storage of decedents who do not fall under OMI jurisdiction.
- Case trajectory prediction is currently difficult, the goal is to remove the refrigerated trucks off-site as soon as possible.

Dr. Jarrell stated that there is nationwide forensic pathologist shortage. OMI hired two more forensic pathologists who started in August. This brings the total forensic pathologists at OMI to seven. OMI needs ten. OMI hired two current forensic pathology fellows. They will begin next fall.

Research & Public Service Project Expansion Request (RPSP):

Dr. Jarrell will present a Research & Public Service Project Expansion Request to the legislature. The request is for \$1,723,000.

- Over the past 3 decades, the OMI has grown along with the state's needs for OMI services.
- Current state appropriations are \$5,744,200.
- Current state appropriations cover 46% of OMI's budget.
 - o FY1991, OMI budget 90% covered by state.
 - o FY2014, OMI budget 65% covered by state.

OMI must generate revenue. This is largely done by issuing cremation permits. Cremation permits are required to cremate a body in the State of New Mexico. They can only be obtained by the OMI. New Mexico's cremation permit fee is one of the highest in the country. The cost is \$200 plus a handling fee. Other medical examiner offices charge \$50 or less to issue. Funeral homes charge this fee to the family. Dr. Jarrell noted to the board that her long-term vision as Chief is to increase state appropriations so that OMI can cover operating expenses and decrease cremation permit fees.

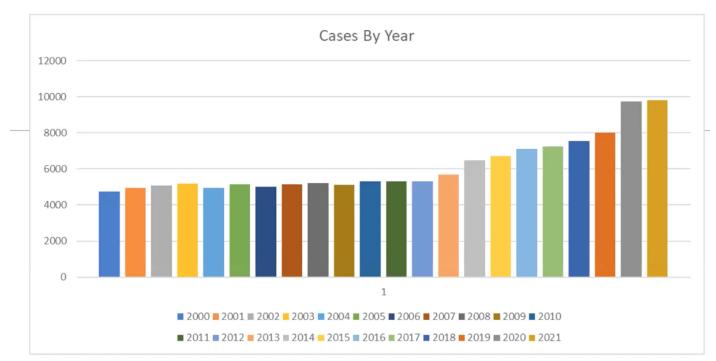

Dr. Jarrell presented a slide and discussed the OMI caseload trend.



Primary reasons for Expansion

- Increase state appropriation to cover at least 55% of operating expenses
- · Create additional staffing support as caseload increases
- · Create additional forensic pathologist position
- · Support toxicologic testing for cases

6. **BUDGET UPDATE:**

Dr. Jarrell presented a slide to the board and gave an update about the OMI budget. Dr. Jarrell highlighted the Body Transportation expense. Historically this has been OMI's biggest expense. The OMI is a statewide jurisdiction and therefore must transport decedents from all over the state to the OMI when an examination is needed. There may be an increase in transportation. One contracted employer is requesting cost per mile increase from \$1.72 per mile to \$3.14 per mile. This would increase OMI's budget an additional \$726k.
